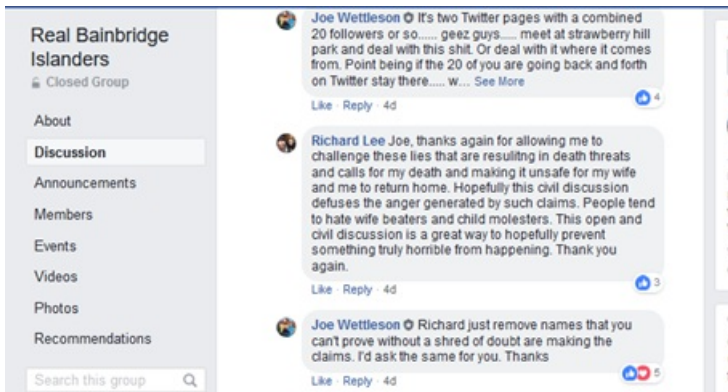

We have been made aware through common friends who are able to see his posts in "Real Bainbridge Islanders" that the allegations were made and this post especially was troublesome. Either he thinks we are a physical threat (hardly) or he is making a veiled threat.



I don't know what if anything is to be done; however, I am maintaining a watchful eye and great distance from the man.

I looked at the paperwork you left with us after last week's meeting and the email from Bonnie below. I do not see any criminal law violations in these social media postings or dialogue. With respect to criminal law- people are generally free to speak and write what they wish, no matter how objectionable, disrespectful, untruthful or profane. There may very well be civil remedies available for you to explore such as; civil protective orders, civil lawsuits, etc. If you are interested in pursuing these, the phone number for municipal court is 206-842-5641 and they are located at 10255 NE Valley Rd. Or you could consult with an attorney about a civil law course of action. Thank you for taking the time to provide the documentation to look at and I hope that issues can be worked out for you.

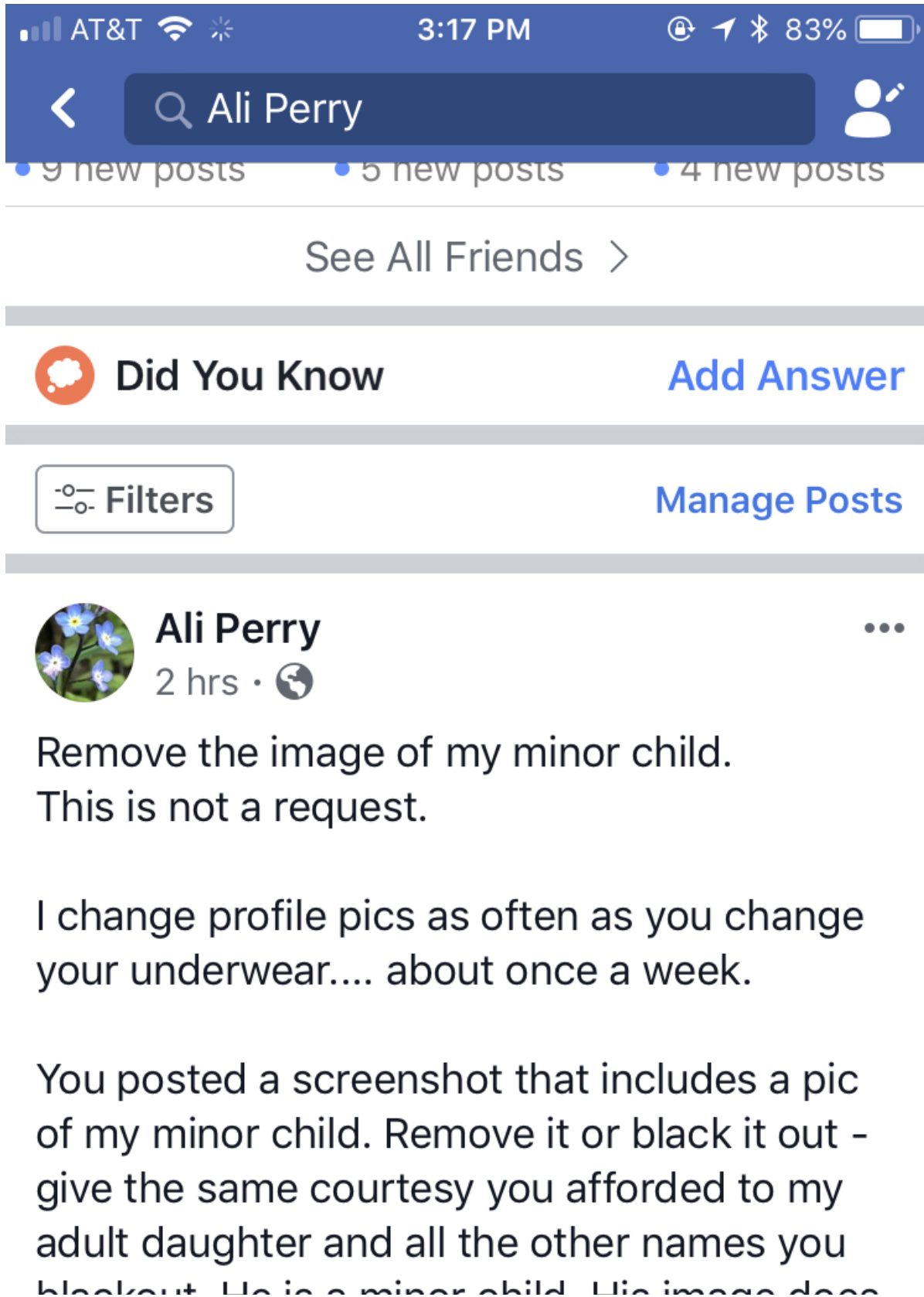

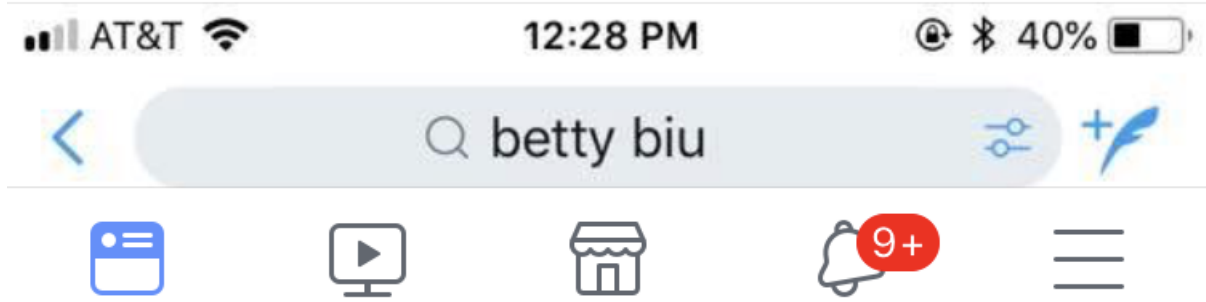
