**Response To: Motion To Quash In The Alternative Terminate Harassment
Protection Order**

For clarification, there is not a dispute between the respondent and petitioner, or an issue would allow any mediation to be productive. We unfortunately need protection from the respondent because she has made multiple threats of harm to my property and person. I am concerned that modifying the protection order will result in emboldening the respondents already impulsive and erratic behavior.

The respondent's sister, Margaret Dufresne, is acting as her own General Contractor to build a home next door to me. Margaret has stated that she expects the project to take 2 more years to complete and she plans to sell the property. The respondent, Flora Dufresne, is not a construction worker at the job site and has no real reason for being at this job site other than to harass me. Margaret quitclaimed Flora onto the title after the protection order was given by the Municipal Court. As you can see there was no percentage or dollar amount transferred in the Quit Claim Deed. The property quitclaim deed serves only the purpose to take advantage of the system in an attempt to remove the protection order

Flora Dufresne has made me aware of the fact that she has acquired a concealed pistol license and a gun and is packing it as she wanders around in front of and nearby my home for hours, as seen in the attached videos and later emails. The respondent's sister, Margaret, has said in the attached email that the respondent is "bi-polar, among other things, and very sick" telling me in the attached video

that she has no control over the respondent. The respondent has demonstrated and insisted, in the attached email, that she cannot control herself and is perfectly happy to get in "trouble".

Both the respondent and her sister have fixated on me and have made it abundantly clear that they intend to cause me and my property harm in any way possible. Both the respondent and her sister have clearly demonstrated that they are unstable, criminally minded, hostile and potentially violent. This unfortunately is not new behavior on her part against me but is a renewed and escalating effort to intimidate me. It began the day I moved in 4 years ago

My fiancée and I have temporarily fled our dream home and are currently living at a friend's house because we fear for our safety. This is taking a massive financial, emotional and health toll on us.

In short, our contention is that the Municipal court was not out of line with the original protection order. This protection order is critical to protect my personal, financial and emotional safety. Please consider returning the order back to its original guidelines with the 1000 feet restriction as we sincerely believe that our lives and property are at stake here.
