To repeat my original point, this could get interesting for Houston.

Another is that an admin IMO should model a higher standard of behavior. If the majority of admins agree with not only disallowing nom de plumes (a reasonable guideline given FB's own Code of Conduct) but setting the tone that it's ok to expose and accuse community members, it sounds like they've lost their way.
