Our decline reason – Suspect Did Not Commit The Crime

Victim in this matter is Bainbridge Island Judge Sara McCulloch. The judge was aware of a Facebook page, "Bainbridge Uncensored," that had been created by the suspect for the purpose of criticizing the judge in regard to her decision to issue a lifetime civil anti-harassment order in which the suspect was the respondent. The judge had no issue with the Facebook page and its criticism of her but did want to make a report about some of the comments that were generated by unknown guests to the page that caused the judge concern regarding her personal safety.

We will monitor any future referrals carefully, but at this time this suspect has not committed a crime.

Note – After speaking with the Deputy Prosecutor who made the decision to decline to prosecute, you may appeal the decline decision to Felony and Juvenile Division Chief Chad Enright, District and Municipal Division Chief Justin Zaug, or Prosecuting Attorney Tina Robinson

SOURCE OF ACTIVITY:

On November 22 of 2017 at approximately 1240 hours, I was dispatched by CENCOM for a harassment detail at the Bainbridge Island Municipal Court.

INVESTIGATION:

I responded to the court and contacted the reporting Party, Bainbridge Island Municipal Court Judge, Sara McCulloch.

McCulloch informed me that the issued at hand revolved around a ruling that she had made against a Richard Lee Rynearson III earlier in the year. McCulloch explained that she had a hearing between Clarence Moriwaki and Rynearson in which Moriwaki was petitioning for a civil order against Rynearson. The hearing resulted in McCulloch granting Moriwaki the order against Rynearson which Rynearson was displeased about.

McCulloch told me that she had learned recently from some personal friends that somebody had created a new Facebook page "Bainbridge Island Uncensored." McCulloch reviewed the page which had Rynearson and his wife, Hyland Hunt, marked as the administrators of the page. The page was used to criticize the handling of his case and to express his own views on 1st amendment rights, which McCulloch.

McCulloch told me that she had no qualms with the page as it was perfectly legal to publicly criticize a public figure. However, her concerns arose from the fallout from all of the attention the page has gathered. McCulloch provided me with some screen shots of posts and responses from the page which she said made her feel uneasy about her safety.

I reviewed the posts and responses which ranged from support of the her decision with Rynearson's case, dissent over her decision with Rynearson's case, crude sexual insults, people calling for her removal from office and/or jailing, to comments that people should be allowed to execute corrupt public officials.

Two specific posts that stood out more than the others were the following:

A Joel Pruitt wrote, "Back in the good old days we shot Tyrants for such things smh. Freedom and Liberty are nothing but a myth in America anymore:(" and, "In didn't advocate violence at all. Although i can guarantee peaceful protests will get no one anywhere. Vote the pos Tyrants out of office and take back Our Government or Plan B."

Shawn Wittenbarger provided a link to McCulloch's personal Facebook page writing, "The "honorable judge" is on Facebook."

McCulloch also provided me a screenshot of a private message she received from a "Jesse Phillips" incident to the new page.

Phillips wrote, "Hi sara how are you. How do i add you as a friend. Do you remember when you had some remodeling done on your house i do i remember working on it lol i was young then.. well its sunday funday so have a good day. Please don't let no one try to contradict your decisions or make you feel bad for your judgement keep smiling it's BEAUTIFUL"

McCulloch told me that Phillip's post was taken down the day after he posted it on November 19 of 2017.

I did not find any of these 3 posters in I-Leads, but did see a Jesse Allen Phillips who had a booking photo similar to the profile picture for the Jesse that sent McCulloch the message.

McCulloch told me that all of the posts were innocuous to her, but still made her uneasy about her safety. She had heard stories about other judges ignoring people getting incited about their rulings and then later being attacked in their homes.

McCulloch asked that the police conduct patrol checks around her home when we have spare time to prevent any potential attacks.

Senior Police Clerk Kelly Eisenhood completed a Patrol Check Request and entered it into the Patrol Binder at the station.

I reviewed Rynearson's personal Facebook page and the "Bainbridge Island Uncensored" page and did not observe any signs of criminal activity. The "Bainbridge Island Uncensored" page did list Rynearson and Hyland Hunt as the administrators of the page.



I am by no means a legal expert, but the page would appear to violate the protection order, and may construe a history of behavior now that you are a target.

I also wrote Ryneerson's attorney informing him of the page. He has acknowledged receipt, and as of today the administrator of the page has begun chastising rather than encouraging the lewd comments while simultaneously "liking" or "hearting" said comments.

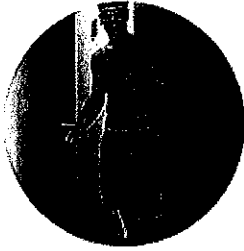





I hope that you and those close to you had a very Happy Thanksgiving holiday.

Mine, not so much.

I am very frightened and threatened by the continued actions of my cyberstalker Rynearons/Lee.

Despite his PPO, Rynearson/Lee is continuing to on-line cyberbully, harass and defame me with his two Facebook pages, Bainbridge Island Bubbles and Bainbridge Island Uncensored.

The crux of this stems from fallout from what I sent to you a link a few weeks ago, a propaganda video that Rynearson/Lee produced and aggressively promoting worldwide attacking me and BIMC Judge McCulloch.

I am blocked from his Facebook pages, but you should be able to see it. Friends of mine have provided me with some of the more threatening screenshots before they were removed, as well as providing proof that despite Rynearson/Lee's denials that he is clearly the creator of the pages, all of which are attached below.

On the video he falsely states the PPO, deliberately stoking an atmosphere among viewers and his followers of hatred and retaliation towards me and the judge, with many of them saying that they outright want to kill us. The video also gives detailed directions to my home, including a red spot on my condo like a target.

While I am told that he has removed some of these posts, that is not enough.

As you can see from the attached screen shots, Ryneerson/Lee never does disavow, counter nor discourage any of the comments or attacks against me nor the judge, which including threats to kill us. Indeed, he actually "likes" many of them.

You may go see these pages for yourself. I am told by my friends that Ryneerson has never disavowed nor discouraged any of these comments of violence and murder, let alone just simply having the common decency to state that he will not allow such threatening statements to be allowed.

Ryneerson's silence is demonstrable complicity that endorses these threats.

I am not over reacting. Ryneerson/Lee is deliberately and demonstrably attracting irrational, angry people who believe him wholeheartedly, some of whom are willing to publicly state actions of violence.

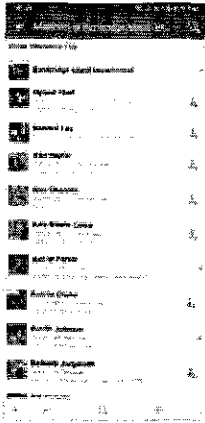

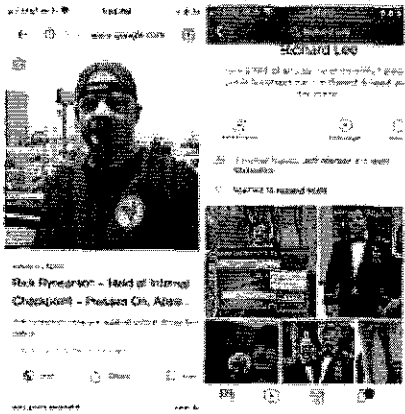

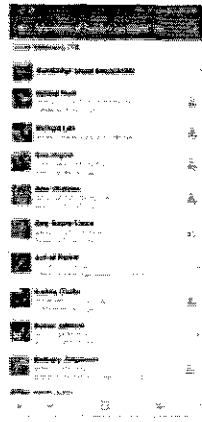

On December 8 of 2017, I received emails from Judge McCulloch regarding new disconcerting messages made on the Bainbridge Uncensored Facebook page.

The comments were made by a Joshua Zinn, a Daniel Quinn, and a Keith Adams.

The messages from Adams mentioned that he though judge`s aught to have a extra protections due to the nature of their work and suggested that the judge "had better watch her back." The message did not express a threat and could be construed to mean that he thinks that judges need to be guarded because being one is dangerous.

The message from Zinn read that he would be "happy to beat the living shit out of that traitor of a judge." The message did express a threat to Judge McCulloch. I looked into the name and Zinn`s Facebook page listed him as living in Spokane Washington across the state from the judge. I searched the name in I-Leads and did not find the name listed in the database suggesting that he has not been involved with any police activity in Kitsap County as of this report. Because of this evidence corroborating the idea that Zinn would be in Kitsap county and thus able to follow through with this threat does not exist as of this report.

The message from Quinn read that "She is a FASCIST, then it`s our duty to hang her publicly as a country as an example of how you take of that filth." The administrator of the Bainbridge Island Uncensored page condemned Quinn`s comment and accused him of trying to make violent comments on the page for the purpose of making the page look discredibile. Quinn responded that he meant what he said. Quinn wrote that he was "just a disgruntled AMERICAN that can`t understand how you retards let this dumb broad get into a position of JUDGE and this country was still not full of socialist fascist commies she would be hanging." The message did express a threat to Judge McCulloch.

I looked into Quinn`s name and his Facebook page listed him as living in Port Orchard which is not far from Bainbridge Island. I checked the name in I-Leads and got a return for a Daniel James Quinn (1/22/1975) of Port Orchard. He had booking photos that matched his Facebook photos.
