1 1. The name of the bank or association, branch address thereof, type of account and
2 current balance for all checking and savings accounts of any kind maintained by Mr. Wade together
3 with copies of all bank statements for the proceeding twelve (12) months.

4 2. Copies of all real estate contracts under which Mr. Wade is purchasing real
5 property, and any other explanatory material or documents related thereto including a statement of
6 balance due thereon.

7 3. Copies of all real estate contracts under which Mr. Wade is selling realty or
8 otherwise collecting money for the sale of real property, and any other explanatory material or
9 documents related thereto including a statement of balance due thereon.

10 4. Copies of all other promissory notes, contracts receivable, accounts receivable or
11 any other evidence of indebtedness whereunder Mr. Wade has or will have money due to him
12 including real estate brokerage commissions, and any other explanatory material or documents
13 related thereto including a statement of balance due or to become due thereon.

14 5. Copies of all income tax returns for the previous two (2) calendar years filed by the
15 Mr. Wade.

16 6. Copies of all earnings, wages, interest and income statements provided by any
17 individual or entity to Mr. Wade for the last twelve (12) months.

18 7. Copies of all books, records, financial statements, earnings statements, loan
19 applications, balance sheets, list of assets, and statements of net worth prepared by Mr. Wade or
20 furnished to any lending institution, individual or entity by Mr. Wade within the last two (2) years.

21 8. The make, model, year, serial number and license plate number of every vehicle in
22 which Mr. Wade has an interest, and the names and addresses of any lien holders thereon.

1 9. The name and address of any insurance company insuring Mr. Wade, the number
2 of the policy of the insurance and the cash value of the insurance policy.

3 10. A complete list of the names and address of every person (including corporations
4 and other legal entities) that owes Mr. Wade any money and the amount that each person owes
5 Mr. Wade.

6 11. Information as to employment for the last three (3) years including name and
7 address of employers, length of time employed, rate of compensation, when and how paid, and
8 whether or not Mr. Wade has any back pay due. The preceding to apply to second or part-time
9 jobs as well as principal employment and to recurring seasonal employment in which Mr. Wade
10 is not now presently engaged.


11 12. A complete list of all contracts of employment, construction, fabrication,
12 manufacture, or rendering of professional or skilled services for compensation not listed in number
13 6 above, including the full name and address of the other party and the amount presently due or
14 anticipated.

15 13. A complete list of all assets Mr. Wade owns or has any interest in, including but
16 not limited to stock, mortgages, notes, judgments, causes or action, copyrights, patents,
17 trademarks, trade secrets, bonds, debentures, coupons, accounts receivable, contract rights, interest
18 in postal savings accounts, any negotiable instrument, contents of safety deposit box, if any,
19 uncashed checks, household furniture, musical instruments, vehicles, boats, airplanes, implements,
20 machinery, tools, sporting equipment, jewelry, objects of art, stamp or coin collections, cash
21 wherever located, legacies or devises in any will now in probate, including property passing by
22 intestacy, interest in a partnership, or any other alienable right or property.

2 suffered within the last three (3) years including a description of the asset transferred, the value of
3 the asset the name and address of the transferee, the consideration received, the date of the transfer
4 and the current location of the asset.

7 PLACE THEREOF WILL CAUSE THE COURT TO ISSUE A BENCH WARRANT FOR
8 YOUR APPREHENSION AND CONFINEMENT IN JAIL UNTIL SUCH TIME AS THE
MATTER CAN BE HEARD.
